Battle of Valcour Exhibit Opening As an institutional partner with the Lake Champlain Maritime Museum's Valcour Bay Research Project, the CCHA will be having an "Open House For Members Only" on October 12, from 9:00 a.m. until 12:00 Noon. The Museum at 48 Court Street will be open during these hours so that our members may get the "first glimpse" of Revolutionary War artifacts prior the opening of the Museum to the public.

Featuring conserved artifacts including an exploded cannon, cartridge box, and a hand axe recovered from Valcour Bay, site of the 1776 battle between the American forces under Benedict Arnold and the British forces under Sir Guy Carlton, these artifacts contain a snapshot of this significant battle.

The Museum will be open to the general public free of charge on October 12<sup>th</sup> from 1:00 p.m. until 4:00 p.m., and resume normal hours and fees on October 15.

This exhibit will be on loan to us from the Lake Champlain Maritime Museum. We are fortunate in that the timing of the exhibition opening coincides with the 226th anniversary of that historic event.
